Bolivian import charges include domestic taxes (most of which are creditable to the Bolivia Tax Authority) and private fees, making effective costs considerably higher than the stated tariffs. Landed costs generally include the following: Cost, Insurance, and Freight (CIF) value at the border. Bolivian returning must have lived abroad far more than two (2) years consecutive, their visits to Bolivia within this period must not exceed ninety (90) days in sum. Franchise for Bolivian returning must not exceed the value of \$35000 (thirty-five thousand American dollars) (FOB VALUE) duty free. In Bolivia, the general import regulations are governed by the National Customs Service (ANB) and are aimed at controlling the flow of goods into the country while ensuring compliance with applicable laws and regulations. Some key import regulations in Bolivia include:

- These regulations are designed not only to facilitate cross-border commerce but also to protect. In order for a natural or legal person to carry out an import, they must previously register in the Register of Foreign Trade Operators of the National Customs, through one of the following modalities. PRESENTIAL MODALITY (Habitual Importers) Under this modality, legal persons, including sole. All imported pets must be accompanied by an official government certificate. All plant and meat products being imported into the country will require a sanitary or phytosanitary certificate from The.
